To designate a population as a DPS takes information on genetics, movement, and population structure. To be listed as Threatened requires population status and trends, a full assessment. This information comes from publications, reports, and long seasons of HARD WORK!!! George is the single authority on the Hawaiian green turtle (Honu) and it is from his dedication and long-lived career as a turtle biologist that we have these designations today! The Hawaiian green turtle is recovering, on the road to recovered, and will most likely be de-listed in our lifetime. This will be grounded in George's life work.

George is as active and strong as ever in the marine turtle community, he is a Board member of the International Sea Turtle Society, leading his own NGO for sea turtle research and consultation, and is the Chair for the IUCN Oceania Region. I look forward to continuing our relationship as friends, colleagues, co-authors, and just old time turtlers...
